**NOTICE**

Sub:- Estt-LSGD-Engineering Cadre- Seniority list of Second Grade Overseers- reg.

Ref:- Order No. E5/202/2009/CE/LSGD Dated 31.07.2009.

There are 477 Numbers of Second Grade Overseers absorbed in Local Self Government Department Engineering cadre from different sources as optees from Public Works Department and Irrigation Department, compulsorily merged from Urban Affairs Department and Panchayath Department. As per the information gathered/received from different sources two Second Grade Overseers from Public Works Department and 10 second grade overseers from the list of Irrigation department were not included in the seniority list so published. In the seniority list there are 465 Second Grade Overseers out of which 441 numbers have been assigned their rank. The service details of remaining 24 second grade overseers have not been received either from their parent department or from the incumbents concerned.

2. Now 15 Second Grade Overseers from the listed 24 numbers have furnished their service details and requested to assign their rank in the seniority list. Also Sri. M. Ananthakrishnan, Second Grade Overseer has joined in the LSGD Engineering cadre as mentioned in the order cited and now he has requested to include his name in the seniority list. Accordingly it is decided to assign the rank of these 16 second grade overseers and noted in Table-A (Annexure).

3. In TABLE- B there are 3 second grade overseers out of which details Sri. K.K. Chandran have not been furnished either by his controlling officer or personally. Sri. K.R. Rajan has not yet joined in LSGD and Sri. Joseph. T.M. is still working as Third Grade Overseer in LSG department.

4. In TABLE-C there are six second grade overseers. As per the service details received from their parent departments, these incumbents are expired/retired
5. As mentioned above there are 441 numbers of Second Grade Overseers who are assigned ranks in the seniority list published vide order cited. On scrutiny of the petitions received from these overseers it is revealed that the rank assigned in the seniority list already published will have to be changed to certain persons. Request from certain overseers are to be finalised by their parent department. Actions are being taken to refer such requests in their parent department. The revised ranks can be assigned to them if necessary on receipt of the details from their parent department.
