- D.D.Os under LSGD North Circle / South Circle : Should submit the consolidated statement collected from the respective Municipalities, including the statement from the Circle Offices also.
- D.D.Os under Municipalities : Should submit the statement to the concerned Circle Offices
- D.D.Os under Corporation : Should submit statement directly to CE office.
- D.D.O. under K.S.R.R.D.A. : Should submit the consolidated statement collected from all P.I.Us, including K.S.R.R.D.A.
- D.D.O. under P.I.Us : Should submit the statement to K.S.R.R.D.A.

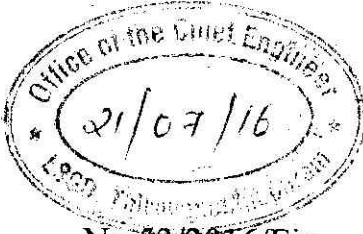
