**Sub: PLGEA – MPLADS – Guidelines regarding execution of works by Beneficiary Committee – Reg.**

As per letter cited first, Government clarified that all the MPLADS works with estimate of Rs. 5 lakh and above, but less than Rs.15 lakh should be undertaken through tendering. And all MPLADS works with estimate less than Rs. 5 lakh could be undertaken through beneficiary committees. Later, in the light of the G.O cited second above, Government directed that all MPLADS works with estimate cost above Rs. 50,000/- , but less than Rs.15 lakh should be undertaken through tendering and all MPLADS works with estimate less than Rs. 50,000/- could be undertaken through beneficiary committees.

2. In the MP's Conference held on 06.07.2017, the MPs requested that G.O applicable to MLA Asset Development Fund should be made applicable to MPLADS works also. Government have examined the matter and have decided to adopt the guidelines for civil works under MLA SDF/LAC ADS for MPLADS also. Therefore, the directions given as per letter cited third are revoked and

following clarifications are made.

- a) All MPLADS works with estimate of Rs. 5 lakh and above, but less than Rs.15 lakh shall be undertaken through tendering.
- b) All MPLADS works with estimate less than Rs. 5 lakh may be undertaken through beneficiary committees.

3. It is also clarified that the execution of all works under MPLADS shall be subject to the Circulars/Government Orders issued by Finance Department from time to time.
