Ref:- G.O. (P) No. 259/2010/LSGD dated 08.11.2010

As per the Government Order cited, Guidelines for Procurements of Goods and Services in Local Government Institutions were issued in conformity with the Stores Purchase Manual for ensuring transparency in the procurement of goods and services. It has come to the notice of the Government that some of the Local Self Government Institutions are going for inferior material without sticking to the Government Instructions. This is injurious to the public interest. Unless public money is spent on materials which are long-standing with quality, the finance of the respective institutions will suffer and the beneficiary will only be the suppliers.

In the above circumstances, all the Local Self Government Institutions are further directed to follow the procedures stipulated in G.O. (P) No 259/2010/LSGD for procurement of goods and services. In cases, which are not covered by the above Government Order, relevant provisions of Store Purchase Manual may be followed.

Any laxity or omission in the matter will be viewed seriously.
