Final seniority list of First Grade Overseers/Draftsman who have opted the LSG Engineering Cadre from Public Works Department and Irrigation Department and those merged from Municipalities and Corporation, Panchayath Department, Rural Development (Defunct) Board etc. was finalised and published vide order read as Ist. But the first Grade Overseers (Juniors) who have been absorbed in the LSGD Engineering Cadre from Public Works Department and Irrigation Department were not included in the final seniority list already published. Such employees were also included in the seniority list by giving their rank in the appropriate places based on the special Rules vide GO(P) No.272/2007/LSGD dated 27.11.2007 after absorbing all the formalities vide order read as 2nd.

The Project Director, Poverty Alleviation Unit, Palakkad vide letter read as 5th has submitted an application received from Sri.O.P.Jagannivasan, First Grade Overseer, requesting to re assign his rank as No. 92(a) instead of 141 in the final seniority based on his date of effect of promotion as First Grade Overseer. It is reported that Sri.O.P.Jagannivasan, while working in PWD he has been promoted as First Grade Overseer vide order No.EB4.31716/91 dated 13.07.2004 of Chief Engineer, PWD Administration. In the said Order it was clearly specified that the promotion was effected from the date of promotion of his juniors already promoted. On verification of the documents furnished by Sri.O.P.Jagannivasan his junior was promoted on 21.08.2003. Hence he is eligible to get seniority in the cadre of First Grade Overseer with effect from 21.08.2003.

Under the above circumstances and considering the request of Sri.O.P.Jagannivasan his rank in the final seniority list of First Grade Overseer is

refixed as 92(a) instead of 141 already published vide order read as 1st and 4th cited
Necessary correction will be made in the seniority list of first grade Overseer.


