As per the provisions contained in the Government Order read as 1st, 25% of the cadre strength of Junior Superintendents of this Department is entitled to get Ratio Higher Grade. This Department has strength of 18 numbers of Junior Superintendents. Against the total strength of Junior Superintendents considering the 25% of the total strength. Sanction is hereby accorded to the following Junior Superintendents Ratio Higher Grade in the scale of pay of Rs. 18740-33680/-.

As per Govt. Order read as 2nd the Ratio Higher Grade of Junior Superintendents has been augmented to 33% of the cadre strength. Hence two numbers of Junior Superintendents are also entitled to get Ratio Promotion. The Government interalia had created 4 more Junior Superintendent posts vide GO read as 3rd. Thus the total strength of Junior Superintendents have become 22. Considering 33% of the total strength of the Junior Superintendents, two more Junior Superintendents are entitled to get the Ratio Higher Grade. Hence sanction is hereby accorded to the following Junior Superintendents for Ratio Higher Grade in the Scale of pay of Rs. 35700-75600/-.



In the case of retired employees they will be admissible only for a maximum period of One year from the back date of their retirement or upto assigned date of Ratio Higher Grade, as stipulated in the GO read as 4th paper in accordance with Rule 23(C) of Kerala Service Rules Part I.
