**ORDER**

A separate Engineering Cadre was created in LSGD as per GO read as 1<sup>st</sup> paper above and started functioning with effect from 01-01-2008. The Special Rules for the Kerala Local Self Government Engineering Service consisting of the Chief Engineer, Superintending Engineer, Executive Engineer, Assistant Executive Engineer and Assistant Engineer were notified as per S.R.O. No.995/07 dated, 27<sup>th</sup> November, 2007 prescribing the methods of appointment, qualification etc. for those posts. But in the Special Rules a ratio for the promotion to the category of Assistant Executive Engineer from among Direct Recruittees and Diploma Holders in the feeder category was not specified. Due to this omission the Seniority List of Assistant Engineers could not be prepared and promotion to the post of Assistant Executive Engineer could not be effected. In the Special Rules for Kerala Engineering Service 1965, it was specified that vacancies in the category of Assistant Executive Engineers shall be filled up from among Assistant Engineers between Degree Holders and Diploma Holders in the ratio 3:1. Hence an amendment namely; the Kerala Local Self Government Engineering Service (Amendment) Special Rules 2009 was notified as SRO. No.620/09, incorporating the note in Sub Rule (1) of Rule 3 after category 4 that " promotion to the category

of Assistant Executive Engineer shall be made from among direct recruitees and Diploma Holders in the feeder category in the ratio 3:1".

2. Challenging the above amendment WP(C) No.24284/09 was filed by Shri. Sulfiker. N and others in the High Court.

3. As per GOs read as 2<sup>nd</sup>, 3<sup>rd</sup> & 4<sup>th</sup> papers above, provisional promotion to the cadre of Assistant Executive Engineer were ordered considering the exigency and subject to decisions in Court cases.

4. The Chief Engineer, LSGD vide letter read as 7<sup>th</sup> paper above has reported that Hon'ble KAT in its order dated 28-10-2014 in TA No.228/14 of WP (C) No.24284/09 filed by Shri. Sulfiker. N and connected Transfer Application quashed the amendment made to the Special Rule vide GO (P) No.133/2009/ LSGD dated 16-07-2009 and the provisional seniority list of Assistant Engineers published by Chief Engineer based on the amendment.

5. In this situation the seniority of the Assistant Engineers have to be reckoned based on the provision contained in clause 2 (2) (v) of the Special Rules for the Kerala Local Self Government Engineering Service. As per this clause the rank and seniority of Assistant Engineers absorbed to this cadre shall be determined on the basis of the date of appointment and seniority in the respective category in the former service and if he/she is a direct recruit in that category on the basis of the date of advice of the KPSC for appoint to that category. As per this rule, the seniority of Assistant Engineers have to be fixed purely based on the date and seniority of the KPSC advice/date and seniority of the promotion orders.

6. The Chief Engineer, LSGD vide letter read as 6<sup>th</sup> paper above has further submitted that lack of sufficient number of AEEs in Local Self Government Institutions are badly affecting the proper and timely implementation of various developmental activities in the Local Self Government Institutions. At present there are 50 vacancies of AEEs existing in this cadre. This comes about 1/4 the of the cadre strength of AEEs. The most unpleasant situations is that most of those vacancies are in the Northern District of Kerala. Six out of Nine AEE post in Kasaragod District alone are lying vacant. Hence it is highly necessary to post AEE in the vacant posts for the smooth functioning of the Local Self Government Institutions. Promotion after preparing / finalising seniority list and after convening DPC is a time consuming process. In this circumstances the immediate remedy to overcome this grave situations is to provisionally promote the senior most 50 AEs as AEEs. Now there is no stay order or any kind of prohibition in effecting promotions / provisional promotions of AEs to AEEs.

7. In the above circumstances, the Chief Engineer has requested as per letter read as 9<sup>th</sup> paper above to take urgent necessary steps to provisionally promote the senior most AEs included in the provisional seniority list prepared and published as per the Hon'ble KAT's Order read as 6<sup>th</sup> paper above purely based on the Rules stipulated for fixing seniority of AEs envisaged in clause 2 (2) (v) of the Special Rules for Kerala Local Self Government Engineering Service 2007.

8. Due to the acute shortage of Assistant Executive Engineers, implementation of major portion of works including Centrally Sponsored, External Aided, MPLADS, MLA Schemes etc. are at a standstill. This situation results in delay in implementation of works and non-incurring of funds which causes criticism from public and people's representatives. Very long delay has already been occurred in giving promotion in this matter due to the pendency of cases in Courts. Now Government are convinced that filling up of vacant posts of Assistant Executive Engineers in public interest are extremely essential for administrative convenience and also for the smooth functioning of the LSGD Institutions.

9. In the above circumstances, in relaxation of the existing ban on provisional promotions, Government are pleased to provisionally promote 52 Assistant Engineers in LSGD Engineering Cadre as given below in **Part-II** as Assistant Executive Engineers with immediate effect, as per Rule 31(a)(i) of KS&SSR Part-II. On promotion they are posted as such at the stations noted against their names.

10. Smt. Annie. K.S (Rank No. 281 in the provisional seniority of Assistant Engineers) is excluded from promotion since the Chief Engineer, LSGD, vide letter read as 10<sup>th</sup> paper above has reported that Smt. Deepthi. R, Assistant Engineer, Edakkad Grama Panchayat, Kannur has complained that she is senior to Smt. Annie. K.S. Their case will be considered later.

11. The above provisional promotions are subject to review in accordance with the publishing of final Seniority List, proper examination of Confidential Reports, pendency of disciplinary and other cases and regularisation of the same by the Departmental Promotion Committee.
