Government vide GO referred 2nd, created the Local Self Government Engineering Cadre by drawing staff from various sources mentioned therein and Special Rules for the Kerala Local Self Government Engineering Services 2007 were issued as per GO referred 3rd, and notified as Gazette Extra Ordinary.

Government issued guidelines for the creation of the LSG Engineering Cadre as per GO referred 4th and Chief Engineer, Irrigation and Administration, and Chief Engineer, PWD were directed that, if sufficient number of willing hands are not received through options, the balance should be filled up from the junior most candidates in the particular category to maintain the required strength stipulated in the GO referred 1st. As such Government vide GO referred 6th absorbed 60 numbers of First Grade Overseers from PWD. Details regarding the present place of working in respect of the incumbents bearing SI Nos. 5,36,37,45,52,56 and 58 are not provided in the Government Order by which the absorption is effected and the same is not readily available in this office. Posting to such officers will be given after obtaining specific whereabouts. The incumbents bearing SI Nos. 21,39 and 40 have moved in the Hon'ble High Court for exempting them from posting in LSG Engineering Cadre and stay orders obtained accordingly. They will be considered according to the final judgment from the Hon'ble High Court. Incumbent bearing SI.No.57 is on LWA/Not Joined Duty.

In the above circumstances, 49 First Grade Overseers absorbed from PWD are hereby appointed in the LSG Engineering Cadre and are posted to the offices noted against their names. Changes in present office address if any may be brought to notice of the undersigned.

The officers posted in Block Panchayats shall draw their salary and allowances from the Commissioner for Rural Development as existing now till a

common Head of Account comes in force. As there are some offices where there is not even a single overseer, some of the officers are posted to such vacancies. They can be given suitable posting accordingly to the availability of sufficient number of officers in the cadre of 1st Grade Overseer.

The officers appointed are hereby directed to join in the posted stations within 15 days from the date of receipt of this order. The drawing officers concerned are requested to relieve the absorbed officers from PWD immediately.

The date of relief/joining may be reported in due course.

All Executive Engineers are hereby directed to report the details of officers reluctant to join LSG Engineering Cadre if any within one month from the date of receipt of this order. The officers working presently in LSGD are directed to formally join in the new LSG Engineering Cadre.




