The Government vide GO cited Ist and IInd accorded sanction to appoint 13 Engineers having Degree in Civil Engineering or equivalent as qualification and 13 Engineering Assistants having Diploma in Civil Engineering as qualification with remuneration of Rs. 15,000/- and Rs. 10,000/- per month respectively. The expenditure will be met from the concerned institution. Interview was conducted by this office and selected Sri/Smt.....as Engineer/Engineering Assistant and appointed in the Corporations/Municipalities noted against his/her name purely on contract basis for a period of one year from the date of joining. He/she will report for duty where he/she is posted within 7 days from the date of receipt of this order with necessary certificates in original to prove date of birth, qualification, community etc.

He/she shall execute an agreement in the form appended in stamp paper worth rupees fifty (Rs. 50/-) at the time of joining. He/she shall be responsible for all works entrusted and liabilities if any in the works executed by him/her during their tenure and are liable to be terminated at any time based on the report of the Municipalities/Corporations. The candidate appointed shall draw his/her remuneration from the concerned municipality/Corporation where he/she is posted.

The Secretaries concerned may verify the qualification, Date of Birth, Community etc of the candidate so appointed before admitting him/her for duty. If the candidate fail to join duty with in the stipulated time, the fact may be reported to this office immediately without fail. The date of joining may also be intimated at the earliest. This posting is subject to the code of conduct for Elections in Local Self Government Institutions/Legislative Assembly.
