Government vide order read as 1st have ordered to create separate Engineering Cadre in the Local Self Government Department drawing technical staff from Public Works Department and Water Resource Department as per G.O.(MS) No.269/2003/LSGD Dated 05.09.2003, all Engineering Staff of Municipalities and Corporation, All Engineering staff of the Panchayath Department, Poverty Alleviation Units, Kerala State Rural Roads Development agency and the then Rural Development Board. Accordingly necessary Special Rules for the Engineering Subordinate Service was published by Government vide order read as 2nd. Cadre strength of the Local Self Government Engineering Cadre was published by Government vide order read as 3rd.

Government have issued guide lines for the creation of the Local Self Government Engineering cadre as per G.O. (Rt) No. 3426/2007/LSGD Dated 13.12.2007. The Chief Engineer, Public Works Department (Administration) and the Chief Engineer, Irrigation and Administration were directed to obtain willingness of the technical staff in their Department who were willing to join the Local Self Engineering cadre and to prepare category wise list of technical staff and forward the same to Local Self Government Department through their Administrative Department. The Local Self Government Department had absorbed the list of technical staff so prepared and forwarded to Government by these Departments vide order read as 4th

and 5th. Also the technical staff from Municipalities, Corporation and Panchayath Department were merged into the Local Self Government Engineering Cadre. Thus the Director, Urban Affairs Department and the Director of Panchayath Department were prepared the list of 3rd Grade Overseers working in their Department and furnished the same vide letter read as 6th and 7th. Accordingly the third grade overseers noted below have entered in the Local Self Government Engineering Cadre from the above Department

Even though the Third Grade Overseers noted above were absorbed from Public Works Department, 3 Third Grade Overseers viz Sri. V.N. Prasad, Sri.M.H. Majeed and Sri. K.R. Shaji and 13 Third Grade Overseers from Water Resource Department Viz Sri. P.A. Raju, Sri.V. Aboobacker, Sri. E.N. Satheesan, Sri. K.V. Raveendran, Sri. K.M. Rajan, Sri. K. Prabhakaran, Sri. A.S. Mohanan, Sri. P.H. Govidan, Sri. Gopalakrishnan Nair C.R, Sri. G. Krishnan Nair, Sri. Satheesan. K, Smt. Omana. K and Smt. Aisha Jasmin were promoted as Second Grade Overseers during the period between the date of filing options and absorption to Local Self Government Engineering Cadre and some other reasons and hence they had not joined in this cadre. Out of this the absorption of Smt. Aizha Jasmin was subsequently cancelled by Government vide G.O.(Rt) No. 1357/09/LSGD Dated 08.06.2009. Thus the remaining 612 Nos of Third Grade Overseers are working in the Local Self Government Engineering cadre. Provisional Seniority list of these Third Grade Overseers was prepared and published in the website wwwcelsegd.com on 04.06.2009 with direction to file objection if any on or before 30.06.2009. Based on this 11 objections were received from the following Third Grade Overseers.

Personal hearing of these petitioners were held on 16.07.2007 after issuing notice vide letter No. E6-4100/09/CE/LSGD Dated 03.07.2009. On hearing Sri. Sijo Jose, Serial No. 1 has requested to give promotion as second grade overseer with effect from 10.09.2002. Since Local Self Government Engineering Cadre was created with effect from 01.01.2008 all promotions should be given based on the seniority list of each categorise. Hence his request can not be considered. Sri. P.S. Manikandan serial No. 2 has requested to give seniority with effect from 01.12.2003. On verification of the documents produced by him it is seen that the Urban Affairs Director vide Order No. B3-12396/2002 dated 26.11.2003 has issued posting orders based on G.O.(P) No. 32/98/P&ARD Dated 17.05.1999 subject to the conditions that his seniority will be given on the date of joining duty. He has joined duty before the authority concerned on 01.12.2003 and hence his request is considered.

Sri. K.S. Satheesh Babu serial No. 3 has requested to given rank in the final seniority list of Third Grade Overseers. Based on the documents produced by him his request is considered.

Sri. V.V. Vinoy serial No. 4 has requested to give rank and seniority of Third Grade Overseers category after analysing the proportionate share to the employees that have been absorbed/merged in the Local Self Government Engineering cadre. As per Rule 2(2)(5) of the Special Rules of Local Self Government Engineering Cadre stated that the rank and seniority of a person absorbed in this service shall be determined on the basis of his date of appointment and seniority in the respective category in the former service, and if he is a direct recruit in that category on the basis of advice of the Public Service Commission for appointment to that category. Hence his rank and seniority of this category is given to the PSC advice.

Sri. K.S. Sree Kumar, Serial No. 5 has requested to give rank and seniority in this cadre with effect from 06.11.2001. On verification of the documents produced by him he has appointed as Third Grade Overseers by the Director of Urban Affairs Department vide order No. B3-17657/01 Dated 08.12.2006 based on G.O.(P) No. 10/99/P&ARD dated 17.05.1999 with effect from 06.11.2001. Hence his rank and seniority in the category of Third Grade Overseer is given as 06.11.2001.

Sri. B. Bijumon, Serial No. 6 has requested to give seniority with effect from 09.11.2001. On verification of the documents produced by him Sri. Bijumon was recruited as Third Grade Overseer in Water Resources Department vide PSC advice No. RIA (3) -25525/2001/GW Dated 09.11.2001. But later on he was recruited as Third Grade Overseer/Work Superintendent in Urban Affairs Department through PSC vide advice No. RE III (3)-318/2002 dated 30.09.2004. Hence as per prevailing rules his seniority in this category of Third Grade Overseers will be given from 30.09.2004 only.

Sri. K.P. Venugopal Serial No. 7 has requested to give seniority list in the category with retrospective effect. On verification of the documents produced by him it is seen that the Hon'ble High Court in WA No. 2004 on OP No. 3059/1998 pronounced a judgement dated 31.05.2005 stating that the petitioner may be advised in the order of ranking. As such he has been advised by the PSC vide RIA (3)-25525/01/GW Dated 20.02.2006 which is considered as the seniority of this category. Sri. K. Ramesh Babu Serial No. 8 has pointed out that his junior has overlook while preparing the seniority list. On verification of the documents produced by him Sri. K. Ramesh Babu has posted as Third Grade Overseer in Water Resource Department on 28.01.2002. Later on he has been selected as Third Grade Overseer in Urban Affairs Department vide PSC Advice No. RE III (3)-318/2002 Dated 14.08.2002. As such he is eligible to get rank and seniority based on 14.08.2002 only.

Sri. B. Sree Kumar, Serial No. 9 and Sri. R. Dileep serial No. 10 have requested to include their names in the seniority list. On verification of the documents produced by them, their names are included in the seniority list at appropriate places.

Sri. S. Anil Kumar, Serial No. 11, has requested to include his name in the seniority list based on the PSC advice obtained for the category. On verification of the available documents in this office he has been advised by KPSC in Water Resource Department and the Chief Engineer (I&A) had given posting orders as Third Grade Overseer vide order No. ADI (4)-23087/90 Dated 13.08.1993. While working in

WRD he had been posted in Public Works Department on 07/2001. But the conditions incorporated in the posting orders are not known. The details are called for from the Chief Engineer, PWD on receipt of the details his rank and seniority will be assigned.

As mentioned above LSGD Engineering cadre is created by drawing technical Staff from various sources. Their service conditions are different in each Department. The preparation of seniority list of each category is based on the details obtained from different Departments. The details of Service and necessary documents of some of the employees are not available with this office or not obtained from the office of their parent Department. Such employees have not been assigned rank in the seniority list as noted. Their seniority shall be fixed in the appropriate places based on the proof produced by the parent Department by themselves.

As per G.O.(P) No. 272/2007/LSGD Dated 27.11.2007 the appointment of the Third Grade Overseers shall be done by direct recruitment only. Hence the seniority list of Third Grade Overseers are prepared after observing rule 2(2)(5) of Special Rules. But the seniority list of junior most Third Grade Overseers absorbed in the LSG Engineering cadre and newly recruited members through PSC after 01.01.2008 will not be included in the list. Their seniority shall be prepared and published in due course.


