ORDER

As per the Government Order read as first paper above Government have approved the proposal for introducing the Estimate Preparing Software - PRICE developed by Kerala Public Works Department (PWD) in estimation and evaluation of Mahatma Gandhi NREGA works with reference to Central Public Works Department (CPWD) Data and CPWD Scheduled of Rates supported by a new Work Flow Chart. Subsequently the National Informatics Centre -Kerala and the Mahatma Gandhi NREGA State Mission have jointly developed a SECURE Software (Software for Estimate Calculation Using Rural Rates for Employment) and decided to develop an exclusive Mahatma Gandhi NREGA standardised Data. There upon as per the order read as 2nd paper above Govt. has constituted a State Level Technical Committee to review the Observed Data and suggested modifications if any and finally to approve the standardised data.

2.As per the letter read as third paper above, the Misison Director, Mahatma Gandhi NREGA State Misison informed Govt. that the State Level Technical Committe approved the Mahatma Gandhi NREGA Standardised Data consisting of the entire data including the approved Observed Data of PWD (Buildings Division), the Irrigation Department, Ministry of Rural Development and the CPWD and all the Observed Data developed exclusively for Mahatma Gandhi NREGA and requested orders on the following:

- I.NIC Kerala shall incorporate the data & material list based on the MGNREGA standardized Data approved by the State level Committee in the SECURE Software.
- II.In case of addition of any fresh data relevent and required exclusively for MGNREGA, such data shall be developed by the Engineer/Overseer of the Grama Panchayath concerned and the same shall be recommended by the Grama Panchayath Technical Sanctioning Committee (MGNREGA). The recommendation shall be admitted by the Executive Engineer-LSGD of the District and such data can be incorporated in the SECURE Soft by the administrator.
- III.Government of India shall be addressed to share the name of works in the Nregasoft with the SECURE Software administered by the MGNREGA State Mission and NIC-Kerala through Web Services and Nregasoft to be customised in such a way that generation of e-muster rolls will be possible only to those works having Administrative Sanction (AS) and Technical Sanction (TS) through SECURE Software.

3.Furthur the Director, MGNREGA State Mission requested Government to

(i) approve the recommendation of the State level Technical Committee to adopt Kerala PWD approved Local Market Rates (LMR), which are revised periodically, for Mahatma Gandhi NREGA works across the State; and

(ii) Sanction the roll out of SECURE Software using the Mahatma Gandhi NREGA standardized Data approved by the State Level Technical Committee and that all works taken subsequent to the said roll out shall obtain AS/TS only through SECURE Software.

Government have examined the matter in detail and are pleased to accord sanction for the implementation of the SECURE Software as in paras 2(i)(iii) and 3 (i) and (ii) above.
