ORDER

The Director of Panchayaths, in his letter read as first paper above, has submitted the proposal for setting up/modernization of Burial grounds/Gas crematoriums in selected 25 Grama panchayaths.

In the Current financial year 2016-17, an amount of Rs.500 Lakh (Rupees Five hundred lakh only) has been provided under the head of account "2515-00-198-36" for setting up/modernization of burial grounds/gas crematoriums in selected 25 Grama Panchayaths. The period of completion of the project is from April 2016 to March 2017 with proper monitoring by Director of Panchayaths.

The Special Working Group of the Local Self Government Department, in its meeting held on 17/10/2016, after detailed discussion, approved the scheme for issuance of Administrative Sanction.

Government have examined the matter in detail and are pleased to issue Administrative Sanction for an amount of Rs.500 Lakh (Rupees Five hundred lakh only) for setting up/modernization of burial grounds/gas crematoriums in 25 Grama Panchayaths (List of selected Grama Panchayaths are appended as ANNEXURE I) by debiting the expenditure to the head of account "2515-00-198-36" in the current


year's budget provision, subject to the following conditions:

- i) The burial ground/gas crematorium proposed to be established should comply with all statutory provisions applicable and should have proper facilities.
- ii) In addition to Government assistance, the concerned Grama Panchayath will find additional resources for the completion of the project.
- iii) Tender/e-tender and other stipulated formalities shall be followed wherever necessary.
- iv) Store Purchase Rules shall be strictly adhered to
- v) The fund released will be based on actual requirement and receiving the utilization of amount if any already released. Fund released will not be allowed to be parked in banks.
- vi) Post creation and purchase of vehicles are not admissible under the scheme.
